

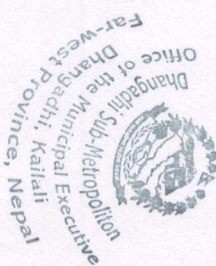

4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kailali at 12:00 pm on 2076/01/18 (May. 1st, 2019)
5. Electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon 2076/01/30 (May. 13th, 2019). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidder's representatives who choose to attend at 2:00 pm on 2076/01/30 (May. 13th, 2019) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in case of bid, amounting Rs. 2,12,000.00, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and security validity shall be recognized with effect from the original bid submission deadline.

In case of discrepancy or error in Tender notice, bid document and other document of Construction of School Building mentioned above reserves right to amend, correct at any time amendment and correction shall be published in the national daily newspaper, notice board of the Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali.
