Bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2076/01/30 (May 13th, 2019) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security amounting to a minimum of 2.5% of the Total Project Cost including VAT, which shall be valid for 30 days beyond the validity period of the bid.

The last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
