The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2075/11/01 (Feb. 13th, 2019) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security which shall be valid for 30 days beyond the validity period of the bid.
