- 5. Sealed or electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egpon or before 12:00 Noon on 2075/11/07 (Feb 19th, 2019). Bids received after this deadline will be rejected.

- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2075/11/07 (Feb 19th, 2019). at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of 2.5% of the Total Project Cost including VAT, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
