4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kailali at 12:00 pm on 2077/11/25 (March 9th, 2021).
5. Electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2077/12/06 (March 19th, 2021). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2077/12/06 (March 19th, 2021) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali, reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
9. In case of discrepancy or error in Tender notice, bid document and other document Dhangadhi Sub-Metropolitan City Office reserves right to amend, correct at any time.
