Bids must be valid for a period of 45 days after bid opening and must be accompanied by a bid security amounting to a minimum of Rupees Twenty six thousand only, which shall be valid for 30 days beyond the validity period of the bid .If bidder wish to submit Bid Security in the form of cash, the cash should be deposited in:
