5. The bids will be opened in the presence of Bidders' representatives who choose to attend at the date mentioned above at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 45 (Forty Five) days from bid submission date and must be accompanied by a bid security amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
