4. Sealed bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi within the time mentioned above. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at the date mentioned above at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 45 (Fourty Five) days from bid submission date and must be accompanied by a bid security amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
