4. Pre-bid meeting shall be held at Dhangadhi Sub- Metropolitan City, Dhangadhi, Kailali at **12:00 Noon on May 27 2022**.
5. Electronic bids must be submitted to the office Dhangadhi Sub- Metropolitan City, Dhangadhi, Kailali through PPMO's e-GP system www.bolpatra.gov.np/egg on or before **12:00 Noon on June 05 2022**. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at **12:30 PM on Jun 05 2022** at the office of Dhangadhi Sub- Metropolitan City, Dhangadhi, Kailali. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **6,10,000/- (Six Lakh Ten Thousand Only)**, which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
