- 5. Sealed or electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2079/08/21 (December 7th, 2022). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 pm on 2079/08/21 (Devember 7th, 2022) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of NRs. 3,10,000/- which shall be valid for 30 days beyond the validity period of the bid.
- 7. The Bidder should have supplied atleast 5 Nos. of Similar High MAST Lightening in any one Fiscal Year within last Five Years.

- 8. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 9. Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali, reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
