


Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Sanchit Kosh (Revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

5. Sealed or electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 Noon on 2079/08/21 (December 7th, 2022). Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 12:30 pm on 2079/08/21 (Devember 7th, 2022) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 3,10,000/- which shall be valid for 30 days beyond the validity period of the bid.
7. The Bidder should have supplied atleast 5 Nos. of Similar High MAST Lightening in any one Fiscal Year within last Five Years.
