A complete set of Bidding Documents may be purchased from Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali by eligible Bidders on the submission of a written application, along with the *copy of company/firm registration certificate*, and upon payment of a non-refundable fee of *NRs. 3000/-* till 2075/02/01 (May 15<sup>th</sup>, 2018) *during office hours*.

Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a>. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Sanchit Kosh (Revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

- 4. Pre-bid meeting shall be held at Dhangadhi Sub-Metropolitan City, Kaillai at 12:00 pm on 2075/01/20 (May 3<sup>rd</sup>, 2018)
- 5. Sealed or electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali by hand/courier or through PPMO's e-GP system <a href="https://www.bolpatra.gov.np/egp">www.bolpatra.gov.np/egp</a> on or before 12:00 Noon on 2075/02/02 (May 16<sup>th</sup>, 2018). Bids received after this deadline will be rejected.
- 6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2075/02/02 (May 16<sup>th</sup>, 2018) at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of 2.5% of Total Project Cost including VAT, which shall be valid for 30 days beyond the validity period of the bid.
- 7. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
- 8. In case of discrepancy or error in Tender notice, bid document and other document of Maintenance of Various Road Section mentioned above reserves right to amend, correct at any time. Such amendment and correction shall be published in the national daily newspaper, notice board of the Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali
- 9. The bidders who submit bids through e-bid must submit the original copy/hard copy within 7 days from the last date of bid submission.
