4. Electronic bids must be submitted to Dhangadhi Sub-Metropolitan City Office, Dhangadhi, through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on mentioned above date. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend. The bids will be opened on the date mentioned above at the office of Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali. Bids must be valid for a period of 90 (Ninety) for IFB No:37/DSMC/2078/079 to 39/DSMC/2078/079 and 45 ( Forty Five ) for IFB No: 40/DSMC/2078/079 to 41/DSMC/2078/079 from the bid opening date and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting mentioned above, which shall be valid for 30 days beyond the validity period of the bid.
6. If the last date of purchasing, submission and opening falls on a government holiday, then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
7. Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali, reserve the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
8. In case of discrepancy or error in Tender notice, bid document and other document Dhangadhi Sub- Metropolitan City Office reserves right to amend, correct at any time. Such amendment and correction shall be published in the National daily newspaper, notice board of the Dhangadhi Sub-Metropolitan City Office, Dhangadhi, Kailali.
